TENDER NOTICE

Sealed quotation affixed court fee stamp of Rs.8.25 (Rupees Eight and paisa Twenty five) only are hereby invited from reputed companies/Firms/ dealers having minimum three years experience in the related fields for the following works at Gauhati Medical College Hospital, Bhangagarh, Guwahati -32, Assam:

Supply, Installation & Commissioning of new Cameras within the premises and configuring them to the existing Video Surveillance and Monitoring System (VMS).

Name of the work Sl.No.2

Operation and Maintenance Service for the Entire System (Existing and Newly Installed Cameras) for three years **as is where is** basis.

Proposals for each work should be furnished separately. Two Sealed separate envelope super scribed with Name of work should be submitted for the above mentioned works. Bidder may participate for either one or both the works separately treating each works as separate unit.

The tender will be received by the undersigned up to 2:00 PM of 16th Sep'2019. The tenders will be opened at 2:30 PM on the same day in the office chamber of the undersigned in presence of the bidders or their authorized representatives.

(A) Scope of the Works:

1. Supply, Insfallation & Commissioning of numbers new Cameras:

The bidder should inspect the site prior to submission of their quotation/ tender and should assess the status of above job and to furnish the report of actual requirement of cameras with specification, brand etc. The new cameras suggested should of best quality and to be configured with the existing Video Surveillance and Monitoring System (VMS).

The vendor will be required to survey the premises and identify strategic locations to place the CCTV cameras so as to have maximum coverage of the work places and other locations.. Number of CCTV cameras likely to be increased or decreased without assigning any reason thereof.

B. The Cost of Cabling will be calculated as per actual usage.

2. Operation and Maintenance Service for the Entire System (Existing and Newly Installed Cameras) for three years.

The Bidder-will provide Operation and Maintenance work for 3 (**three**) years for the entire system (Existing & New) as is where is basis. The vendor will ensure proper function of all the equipments related to CCTV system. The bidder has to depute one skilled operator/technician to operate and maintain day to day operation of the system. All items like Cameras, DVRs and other related hardware/ software etc. should be maintained by the contractor within the contract period. No extra Cost will be paid to the vendor in case of faulty Spares/ repairing or any other related works (irrespective of major problems/spares/parts) during the contract period. The assessment should be carried out with GMCH's authorized person.

The newly installed cameras should be configured to the existing VMS system of CCTV surveillance. Their warranty period of new cameras (company warranty) should not be merged with the cost of three years operation & maintenance.

(B) Terms & conditions:

01. The firm should have local office within the state of Assam with sufficient technical manpower to attend any technical fault within 12 hours. A monthly preventive service report needs to be submitted along with the monthly bill.

02. Onsite support shall be provided by the vendor by way of stationing one technician/operator at GMCH. He should be available in all weekdays including the holidays, and to provide any backup recording if required any time as and when required with due permission from authority only.

03. The rates should be quoted as per item/ work and related installation/ servicing charges including GST (mentioning the rate of GST)

04. The vendor must have supplied and installed at least 3 numbers of CCTV systems of similar type in a large undertakings like reputed Government Establishments/ Public Sector Institutions/ Educational institutions/ Defense establishments / Govt. of India institutions / public utilities viz., airport, railway stations etc., in India and working satisfactorily for a minimum period of 3 years.

05. EMD @ 5% on total bid value (including taxes) for all three works should be accompanied with the Tender in the form of Bank Draft or Bankers Cheque in favour of Assam Trade Promotion Organisation.

06. After awarding the work to the successful bidder, EMD will be adjusted with security deposit. The decision on finalizing security deposit will be fixed by authority after the selecting the contractor. Date of contract agreement or successful work completion report will be taken as reference for this purpose.

07. EMD of unsuccessful bidder will be released only after awarding the work to successful bidder and signing the contract thereof.

08. The work mentioned at 1 should be completed within 30 days from the date of issue of order work order. Separate Order may be issued for Operation & maintenance work i.e. works 2.

09. No escalation of rates will be permissible after receiving the work order.

10. Unsatisfactory work will lead to cancellation of the contract, suspension of payment, and any other action that the Trade Centre Authority may deem fit.

11. The Bidding firm should submit following copies of document along with the proposal:

- Valid Trade License/ Distributorship/ Firm Registration/ Dealership etc. from competing authorities.
- GST Registration
- IT registration with PAN card.
- Past performance certificates/ Work experience (Last Three years)

(C) Other conditions:

01. Last Date of submission of tender is 16/09/2019. The tender should be dropped in the tender box kept in the office Underlining in the envelope the tender Number. No tender will be receipt after the time and date as fixed thereon.

02. Payment will be made only after successful completion of the works as per specification and after fulfillment of all conditions of NIT and subject to availability of fund.
