Supply, Installation & Commissioning of new Cameras within the premises and configuring them to the existing Video Surveillance and Monitoring System (VMS).

Operation and Maintenance Service for the Entire System (Existing and Newly Installed Cameras) for threeyears as is where is basis.

Proposals for each work should be furnished separately. Two Sealed separate envelope super scribed with Name of work should be submitted for the above mentionedworks. Bidder may participate for either one or both the works separately treating each works as separate unit. The tender will be received by the undersigned up to 12:00 Noon of 21/03/2020. The tenders will be opened at 1:00 PM on the same day in the office chamber of the undersigned in presence of the bidders or their authorized representatives.

## (A) Scope of the Works:

## 1. Supply, Installation & Commissioning of number of newCameras:

The bidder should provide two bid quotations (technical and financial in separate sealed envelopes put inside a sealed envelope) for the supply and installation of one item each of the following:

- A. After the end of the technical bid, the vendors/ suppliers shll be invited for a demonstration of the products quoted. Failure to take part in the demo shall be a criteria of rejection.
- B. Vendors/suppliers may inspect the site prior to submission of their quotation/ tender by taking due approval from authority and should assess the status of above job and to furnish the report of actual requirement of cameras with specification, brand etc. The new cameras suggested should of best quality and to be configured with the existing Video Surveillance and Monitoring System (VMS).
- C. At the end of the demo, and financial bit, the recommended vendor/supplier will be required to a detailed survey of the premises and identify strategic locations to place the CCTV cameras so as to have maximum coverage of the work places and other locations. Number of CCTV cameras likely to be increased or decreased without assigning any reason thereof.

- D. The supply and installation of a CCTV network also involves a provision of display of critical areas of GMCH in a unified panel so as to help in effective monitoring of the premises.
- E. The cost of cabling will be calculated as per actual usage and be estimated at the end of the survey as mentioned in (C).
- F. The proposal should have provisions of expandability and scalability in terms of sharing the optical fiber network for VoIP based intercom services, access control using biometric authentication etc.

# 2. Operation and Maintenance Service for the Entire System (Existing and Newly Installed Cameras) for threeyears.

The Bidder will provide Operation and Maintenance work for 3 (three) years for the entire system (Existing & New) as is where is basis. The vendor will ensure proper function of all the equipments related to CCTV system. The bidder has to depute one skilled operator/technician to operate and maintain day to day operation of the system. All items like Cameras, DVRs and other related hardware/ software etc. should be maintained by the contractor within the contract period. No extra Cost will be paid to the vendor in case of faulty Spares/ repairing or any other related works (irrespective of major problems/spares/parts) during the contract period.

The assessment should be carried out with GMCH's authorized person.

The newly installed cameras should be configured to the existing VMS system of CCTV surveillance. There warranty period of new cameras (company warrantee) should not be merged with the cost of three years operation &maintenance.

#### A. Working Hours:

- a) The maintenance work shall be done on 24X 7 basis and in case of emergency, maintenance may have to be done beyond office hours and even on holidays with prior arrangement through proper communication with Hospital Authority.
- b) The maintenance work shall be carried out, primarily, at the GMCH. In case the service provider feels that equipment cannot be repaired at site, they will carry and deliver the equipment at their own cost and get it repaired promptly within the response time agreed upon in the CMC by temporary replacement.
- B. Routine Check-up: The service provider should report this office twice in a month for routine check-up besides visits on call basis as and when required.
- <u>C. Response Time</u>: Call to be attended within 12 working hours.
- **D. Preventive Maintenance**: The service provider shall also carry out periodic preventive maintenance including external cleaning of the items once every month.
- E. Service Engineer/Technician: For regular and proper maintenance of the equipments, the vendor will depute at least one qualified, experienced service engineer / technician. The service engineer/technician should have sufficient and requisite knowledge of maintenance and troubleshooting of the CCTV system.
- **F.** Responsible for backup and storage of CCTV footages month wise which is to be handed over to the authorities of GMCH.

### (B) Terms & conditions:

- 01. The firm should have local office within the city of Guwahati with sufficient technical manpower to attend any technical fault within 12 hours. A monthly preventive service report needs to be submitted along with the monthlybill.
- 02. The rates should be quoted as per item/ work and related installation/ servicing charges including GST (mentioning the rate of GST)
- 03. The vendor must have supplied and installed at least 3 numbers of CCTV systems of similar type in a large undertakings like reputed Government Establishments/Public Sector Institutions/ Educational institutions/ Defense establishments / Govt. of India institutions / public utilities viz., airport, railway stations etc., in India and working satisfactorily for a minimum period of 3 years.
- 04. The firm should have average turnover 20 lakh in last 03(three) years
- 05. The bidder shall deposit a lump sum amount of Rs. 20,000/(twenty Thousand only) with the Tender as a EMD in the form of Bank Draft or Bankers Cheque in favour of Member Secretary, HMS, GMCH.
- 06. The amount of performance security shall deposit Rs. 100000/- (One Lakh) only by the successful bidder before execution of the work. After awarding the work to the successful bidder, EMD will be adjusted with performance security deposit. The decision on finalizing security deposit will be fixed by authority after the selecting the contractor. Date of contract agreement or successful work completion report will be taken as reference for thispurpose.
- 07.EMD of unsuccessful bidder will be released only after awarding the work to successful bidder and signing the contractthereof.
- 08. The work mentioned at 1 should be completed within 30 days from the date of issue of order work order. Separate Order may be issued for Operation & maintenance work i.e. works 2.
- 09. No escalation of rates will be permissible after receiving the workorder.
- 10.Unsatisfactory work will lead to cancellation of the contract, suspension of payment, and any other action that the GMCH Authority may deemfit.
- 11. All legal matters shall be within the jurisdiction of Gauhati High Court.
- 12. Post-sales support services and maintenance is a crucial part of the work and inability of the assigned party to undertake relevant measures to provide a 24x7 CCTV coverage for at least 3 years will lead to serious administrative action like black-listing of the party (including public notification) from all subsequent work in GMCH
