Terms and Conditions:

- 1. The Bidder should visit the site and coordinate with the authority to find out the details of the scope of work required for successful completion of the entire project.
- 2. Bidders are requested to give detailed tender for the scope of work in their own forms under two bid systems Technical and Financial Bid in two separate sealed envelopes superscribing as "Quotation for Renovation of BSL III Laboratory, State Level VRDL" Technical Bid or Financial Bid. The bidders fulfilling the terms & conditions as well as technical specifications will qualify for the Price Bid. Any deviation from the above will lead to rejection of the tender summarily.
- 3. The estimated value will not increase at any cost.
- 4. The bidder should have earlier record of installation of at least one BSL-3 Laboratory.
- 5. The response time in case of break down call for the supplied item/repaired item should not be more than 24 hours. The contact details of the technical person to be engaged by the bidder for repairing works during the warranty and CAMC period must be enclosed.
- 6. Expert technical and application assistance for warranty period is mandatory. The company must have engineers locally available / available on call within 24 hrs of any malfunction. The bidder must have service engineers based in Guwahati.
- 7. The Technical Bid should be accompanied with complete specifications with measurements wherever necessary as per the scope of the work.
- 8. For fulfillment of the scope of work, bidder must make a table with the scope of work advertised and tick those provided by the bidder, any additional facility provided by the bidder should be highlighted below the table.
- 9. Quotation in triplicate must be submitted under proper sealed cover.
- 10. Bidders should have previous experience of supply and successful commissioning of similar laboratories in the last five years. Experiences and satisfactory performance certificate should be attached along with the tender.
- 11. The Tender will be strictly non-negotiable.
- 12. Tender received late/incomplete are liable to be rejected.
- 13. The relevant documents for qualifying requirements stipulated in tender documents above, shall be submitted by the bidder as per the provision of tender documents.
- 14. The work along with successful commissioning of the lab should be finished within the stipulated time (2 months of period w.e.f. date of allotment work order).
- 15. Tender will be accepted from 10 am to 3 pm in working days.
- 16. Duly signed tender document (on each page by the Vendor / Bidder) is to be included with the quotations indicating acceptance of our terms and conditions.
- 17. The payment will be done only after successful completion and commissioning of entire work.
- 18. It is the responsibility of the successful bidder to collect the clearance certificate from **Head of the Department of Engineering Support, ICMR Pune.** This is compulsory before placing the bills to the tender inviting authority.
- 19. Losses/damage of the materials in transits, if any, shall be at the risk of the vendor.
- 20. No advance payment for the cost of instrument or related expenditure shall be made to the vendor.
- 21. For all legal matter court jurisdiction shall be "Guwahati".

- 22. The sealed cover should be superscribed with "Quotation for renovation of BSL III Laboratory, State Level VRDL, GMCH" and "Last date of submission" as notified in the tender notice.
- 23. Mode of payment will be through cheque/PFMS.
- 24. The rates should be valid for at least 1 year.
- 25. The rates should be quoted in words as well as in figures in respect of each item.
- 26. Technical Specifications/Model/Make shall be strictly as per the requirements laid down.
- 27. However, any deviation, if required, may be considered by the Technical Committee, subject to suitability and the needs of the work.
- 28. Over-writing on document, if any, should be supported by signatures.
- 29. The Bidder must have executed similar projects in the last five years. They should submit full address and telephone numbers of customers with satisfactory completion certificates
- 30. Please submit the following documents in sequence in each copy of the tender Documents:
 - a) Forwarding letter duly signed by the authorized person.
 - b) Reg. Certificate of the vendor.
 - c) List of similar projects with full address and telephone numbers of customers with satisfactory user certificates.
 - d) Name and address of registered office, head office, regional office of the company.
 - e) Name and telephone numbers (contact details) of key person.
 - f) Acceptance of all clauses of tender specification duly signed page-wise.
 - g) Average Annual turn over for last 3 years should not be less than the bid value.
- 31. The tender must be accompanied by GST clearance certificate up to 31st March of the preceding year.
- 32. All photocopies, which are required to be attached with the tender, should be attested by the bidder under proper seal.
- 33. Any tender inconsistent with the aforementioned terms and conditions and with the general Terms & Conditions Annexed with tender form shall not be considered.
- 34. Tenders will be opened on specified date in the presence of bidders. A decision in regard to acceptance of Tenders will be taken as soon as possible.
- 35. The successful Bidders will be intimated by letter or other means of communication and the Bidder so informed shall be bound for the timely transmission of such acceptance to the Department. Formal acceptance of the tender will be forwarded to successful bidders in due course but it will serve merely as a confirmation of the initial information.
- 36. The dates stipulated above are fixed and under no circumstances they will be relaxed unless officially extended. If any date specified above is declared as holiday by the Government, the said date is deemed to have been extended to the next working day.
- 37. All rates should be inclusive with all taxes and cost.
- 38. The decision of the technical committee shall be final and binding on the Bidders on any matter relating to technical aspect of the tender.
- 39. For all items including the replaced and repaired spare parts should have five years comprehensive warranty including maintenance of all parameters at desired level for five years and the successful bidder must be ready with all spare parts, consumables, software etc. for another five years after expiry of comprehensive warranty for entering into in CAMC.
- 40. All items should be FDA/CE or equivalent Indian Standard.

- 41. The tender must be accompanied with an earnest money at the rate of 2% of the quoted value in the form of Bank Draft drawn in favour of STATE LEVEL VRDL GMCH. Earnest money in other form will not be accepted. Bids not accompanied by earnest money as stated above or less than the amount stipulated above shall be summarily rejected.
- 42. Earnest money/Security deposits any other sums of the tenders lying with the Gauhati Medical College Hospital, Guwahati in connection with any other tender/case will not be considered against this tender.
- 43. If Technical Committee requires any changes in specifications the supplier shall use his best Endeavour to comply with wishes subject to fair fixation of prices and delivery schedule where appropriate.
- 44. Terms and conditions of Forfeit of Performance Security
 - a. The successful bidder shall be required to furnish performance security of 10% of total bid value by the firm in the form of fixed deposit receipt hypothecated in favour of **STATE LEVEL VRDL GMCH.**
 - b. The performance security will be forfeited on the gross violations of tender norms by the successful bidders.
 - c. Performance security is compulsory and will have to be deposited by each successful bidder.
 - d. Earnest money deposited by unsuccessful bidders will be refunded after completion of tender process. EMD submitted by successful bidder will be refunded on submission of performance security.
 - e. In case the successful bidder is found in breach of any condition/tender at any stage, legal action as per rules/laws shall be initiated against the agency concerned. In that case, EMD/Performance Security shall be forfeited after giving proper opportunity through show cause notice.
 - f. Successful Bidder shall execute an agreement in accordance with these terms and conditions along with performance security.
